Treasurer

We have a new addition to the MHA board, Barb Stafford will be joining us and taking on the role of Treasurer. Welcome Barb!

Pot Holes

Budget

Similar to previous years, in order to avoid a Special Assessment and paying out of pocket when the repairs are required, the attendees at the Annual Meeting agreed that it was best to continue to add to our savings and plan for larger projects in the years to come.

Front Light

As discussed last Annual Meeting, the front spot light had malfunctioned and was subsequently disconnected. We relocated the plug, replaced the spot light with an LED fixture, and replaced the lamp post ballast with an LED as well.

Fence

As in other years, the fence along the business structure to the north, Planet Fitness (previously Farmer Jack), has had delays in getting maintenance done. The building management will be contacted again.
